### Omaha Beach Community Inc. Submission to Auckland Council. Re: Proposed Freedom Camping in Vehicles Bylaw

### 1. Introduction

This document is submitted to you by the Omaha Beach Community Inc. ('OBC') (<u>https://omahabeach.co.nz/</u>), believed to be one of New Zealand's largest funded ratepayer associations, with circa 90% plus of all eligible ratepayers in Omaha Beach as financial members. We currently have some 1,200 paid up members, who are property owners in Omaha Beach.

## We can reasonably claim that the views and opinions expressed in this submission are reflective of the overwhelming majority of residents and ratepayers of Omaha Beach.

Since we first became aware of Council's proposals towards the end of last year, we have undertaken a significant amount of research, and been in regular dialogue with the Local Board, Council, planners and lawyers.

We believe we now have a much greater understanding of the Council's proposals and the implications for Omaha Beach.

The OBC is making this submission to Council, **opposing the bylaw as proposed**, **and requesting a total prohibition of freedom camping in Omaha Beach**. This view is based on what we have learned regarding the proposed bylaw, and its potential impact on Omaha Beach; the views expressed by our members at the OBC's AGM held 20 January 2019, and also from the responses to an online survey undertaken on our members, where 83% of survey respondents were against freedom camping in Omaha Beach. The survey results form part of this submission, and are included as Appendix 10.

## Key reasons for us opposing the Council's Freedom Camping in Vehicles bylaw, as proposed, include:

- We are extremely concerned about the implications of Part 1, Clause 6 of the Freedom Camping Act 2011 ('the 'Freedom Camping Act'), where the local authority area for the Council includes areas of land controlled or managed by Auckland Transport ('AT'); the roads and the numerous parking bays around Omaha Beach and with the default position under the Freedom Camping Act and the proposed bylaw essentially being that ... if a site is not restricted or prohibited under another enactment, and is 'not scheduled' in the bylaw, then freedom camping is permitted. It is our understanding we could therefore see, under the proposed bylaw, freedom campers parking and setting up 'camp' outside and beside people's homes, essentially in any vehicles they like which would be totally unacceptable!
- We believe that the 'not scheduled' areas must have general rules like other councils have used, including not parking outside a private house or business (as seen in Tauranga city) and limits on vehicle type and time periods.
- Freedom Camping is currently prohibited under the Rodney legacy bylaws.
- Our view is that the Freedom Camping Act does not prevent freedom camping being prohibited in some of Auckland Council's areas such as Omaha Beach.
- The Council proposed sites for freedom camping in Omaha Beach are all currently protected from camping under the Reserves Act 1977 ('the Reserves Act'), but Council proposes using a delegated authority from the Minister of Conservation to overturn this prohibition, and allowing freedom camping which we object to, and question.
- Those property owners with properties adjacent to the proposed Reserve sites bought there having the comfort of the Reserves Act to prohibit camping.
- Omaha Beach is a residential settlement, and we do not believe the Freedom Camping Act ever envisaged freedom camping in such areas.
- The Reserves sites proposed by Council, and noted below, even as 'restricted' sites, are totally unsuitable for freedom camping and are strongly objected to:
  - o Pukemateko Reserve, 177 Mangatawhiri Rd,
  - o 160 Omaha Drive (overflow boat trailer parking),
  - William Fraser Reserve, 37 Broadlands Drive

These Reserves are adjacent to residential properties; they are already heavily utilised; there will be a severe reduction of car parks for use by resident ratepayers and visitors if camping sized vehicles are allocated spaces; none of the sites can comfortably accommodate the safe movement of 2-4 berth campervans without significant ground works being undertaken; and they have very limited, or no, public toilet facilities or drinking water available.

• The proposed restrictions on the sites are not realistic and are, we believe, unenforceable.

Whilst strongly opposing freedom camping in Omaha Beach, we have also given careful consideration of other, local, more suitable sites, and comment on these is contained in Section 18. of this submission.

### 2. Executive Summary

- Omaha Beach ratepayers are overwhelmingly opposed to the Freedom Camping Bylaw, as proposed, and to allowing freedom camping in Omaha Beach.
- Freedom Camping is currently prohibited in Omaha Beach under the Rodney legacy bylaws, and this prohibition must continue, due to the unique combination of factors that would otherwise result in a significant negative impact on the access, amenity and safety for all residents and visitors to Omaha Beach.
- The Freedom Camping Act does not prevent freedom camping being prohibited in some of Auckland Council's ('Council') areas such as Omaha Beach.
- The Freedom Camping Act ensures the ongoing protection of the Omaha Beach Reserves through the Reserves Act.
- We are also extremely concerned about the proposed revoking of Rodney District Council General Bylaw 1988: Chapter 8 Public Places, and the implications of losing the no-camping protection in our residential streets and carparks.
- We object to the proposed bylaw with no 'general rules' for the areas classified as 'not scheduled'. Included in these areas are land controlled or managed by AT. We believe including nearly every kerbside and cul-de-sac carpark in our residential streets in the 'not scheduled' category results in unenforceable and unrestricted camping in any vehicle for an unlimited time period. This has significant and extraordinarily wide reaching negative impacts on the amenity, access and safety for the residents and ratepayers of Omaha Beach and the many visitors to the area.
- The impact of freedom camping will be magnified in Omaha Beach due to its immense popularity and accessibility from Auckland, together with the proposed widespread promotion as a freedom camping spot by Council, and also social media.
- The impact and loss of amenity and access will not just be limited to our Reserves but, also our residential streets by having freedom camping right outside our houses across nearly all of Omaha Beach.
- We already experience issues with freedom campers even though it is prohibited (but Council may not be aware of these issues, as we believe they haven't been reported).
- We need ongoing protection of our Reserves and limiting damage and illegal activity in these Reserves, and the streets and cul-de-sacs, across Omaha Beach.
- Omaha Beach is a residential area, and we do not believe it was ever the intention of the Freedom Camping Act to actively promote freedom camping in such areas.
- The Reserves were vested in Council for protection of residents, and it was never contemplated that such a use as camping would ever be permitted on them.
- Those property owners adjacent to the proposed Reserve sites bought there having the comfort of the Reserves Act to prohibit camping.
- All the proposed sites are in built up residential areas, within metres of the nearest houses. The Reserves are all in viewing channels and noise zones of surrounding residential properties.
- We recognise that the two sites in Omaha Beach designated as prohibited in the proposed bylaw are also Reserves where camping is prohibited by the Reserves Act. However we agree that those two Reserves must have their prohibited status continued under any new bylaw and highlighted with signage to this effect. The sites are
  - o 223 Omaha Drive (Omaha Beach Boat Launching Ramp and Wharf);
  - 15 North West Anchorage (Omaha Reserve).
- The Council proposed sites for restricted freedom camping in Omaha Beach are all currently protected from camping under the Reserves Act. We do not support Council using the delegated Ministerial authority to overturn the prohibition of camping in these Reserves, and allowing freedom camping.
- The Reserves proposed by Council, noted below, even as 'restricted' sites, are totally unsuitable for freedom camping and are strongly objected to:

- Pukemateko Reserve, 177 Mangatawhiri Rd,
- o 160 Omaha Drive (Rita Way, Excelsior Way, Lagoon Way),
- o William Fraser Reserve, 37 Broadlands Drive
- These restricted Reserves are already heavily utilised and frequently the traffic overflows through to the surrounding streets.
- There will be a severe reduction of car parks for the use of resident ratepayers and visitors if camping sized vehicles are allocated spaces and access in those car parks, and we maintain that none of the proposed restricted reserves can accommodate the safe movement of 2-4 berth campervans without significant ground works being undertaken.
- The proposed sites have very limited, or no, public toilet facilities or drinking water in the proposed restricted reserves, with no sites having 24/7 water or toilet facilities, and are considered unsuitable even for certified self-contained vehicles.
- None of the proposed Reserves meet any of the criteria set by Council that mitigates the known harms from freedom camping.
- We request the appointment of Insite Security Ltd as a local 'enforcement officer' for Omaha Beach, as is permitted under the Freedom Camping Act.
- We note the obligations on Council to use the special consultative procedure set out in Section 83 of the Local Government Act 2002 ('LGA') for the proposed bylaw. We are of the view that Council have not fully met their obligations under the special consultative procedure.
- Council's consultation process required us to make numerous further enquiries of Council to obtain a full understanding of the proposal, and its implications particularly regarding the significant implications on the access, amenity and safety of the people of Omaha Beach in relation to the inclusion of the AT areas in the 'not scheduled' areas of the proposed bylaw.
- We are also disappointed that, whilst we were made aware of Council's a 'Have Your Say' dropin session in Warkworth, it was held on 16<sup>th</sup> February 2019, giving us only 2 days to finalise our submission before the close of the consultation process – which we believe to be inadequate.
- We do not believe the primary harms, noted by Council in relation to freedom camping, will in fact be adequately managed with the proposed bylaw and will in fact magnify beyond all proportion in the Omaha Beach area the recognised primary harms of freedom camping.
- Whilst acknowledging that a bylaw may be a way of addressing the perceived problems, we maintain that the desirability of Omaha Beach to campers means that **prohibition of freedom** camping in Omaha Beach is the most appropriate and proportionate response.

Spot the difference between these 2 pictures ... They are both freedom camping sites ... although the one at the bottom is of one of the proposed sites in Omaha Beach. Note close proximity to residents, no running water, no toilets facilities Surely this was never the intention when the Freedom Camping Act was enacted?





### 3. Omaha Beach – Unique conservation area already under pressure from visitors

Omaha Beach is located just an hour's drive north of Auckland and 15 minutes east of Warkworth. It is effectively a sand spit, reached by way of a causeway and bridge over the Whangateau Harbour. It has one of the best white sandy beaches, and a popular spot for surfing, within an hour's drive of Auckland city.

The area is considered a sensitive coastal environment, with the residential area protected by dunes, a kahikatea forest/wetland vested in the Crown as reserve, and areas vested as neighbourhood Reserves, with pedestrian access and walkways to the beach carefully planned to protect the sensitive dunes environment.

Omaha Beach is also home to the Omaha Shorebird Sanctuary, managed by the Omaha Shorebird Protection Trust ('OSPT') (<u>http://www.omahashorebirds.co.nz/</u>). The Omaha Spit forms a barrier between the open sea and Whangateau Harbour, a relatively unspoilt tidal estuary. The area is important for a range of native shorebirds, which feed on the estuary at low tide. Some of them, such as the threatened New Zealand Dotterel and the Variable Oystercatcher, nest on Omaha Spit in significant numbers. With the formation of the OSPT in 2009, the community has taken the lead in protecting Omaha's shorebirds and the successes have been very heartening for the community. See also letter from OSPT at Appendix 9.

While Omaha Beach started as a holiday location, it is now very much a residential area, with a fast growing permanent resident population, However, Omaha Beach is also a vital and popular seaside area for tens of thousands of visitors annually within the greater Auckland region and beyond. At times its carparks, boat trailer parking and grass verges are full with the overflow of vehicles to accommodate the visitors. With the numbers of residents, and visitors, swelling dramatically at weekends, holidays, and over the summer period in particular, the facilities and infrastructure of Omaha Beach comes under extreme pressure from under-resourced facilities – as is evidenced by the need for the OBC to arrange twice weekly residential rubbish collections by Northland Waste, and weekly recycling collections by Council's contractor (with the OBC and its resident ratepayers contributing to the cost of these additional collections). At the main beach Reserve (William Fraser Reserve) the only public toilets are inside the surf club building, which are locked at night, and are totally inadequate for the visitor numbers. There is no drinking water for visitors as Omaha Beach is on individual tank water. See Appendix 1- for photos of overflowing car parks in our designated *Reserves*.

Omaha Beach was first developed in the early 1970's, in northern Omaha. Work on the southern end (under the control of the Omaha Beach Residents Society (<u>http://www.obrs.co.nz/homepage</u>) – but under the overall umbrella of the OBC) commenced in the late 1990s.

Over the years the Omaha Beach community has funded and improved many of the services and facilities it has today – such as the golf course, tennis courts, boat ramp, community centre, sewerage disposal system, and surf lifesaving clubrooms.

We do not support placing additional pressure on the already stretched facilities at Omaha Beach by opening up and promoting the additional provision of freedom camping. While the current Reserve sites are unsuitable, as detailed in the following sections, the very nature of Omaha Beach's visitor numbers would see a significantly magnified and negative impact from the recognised 'primary harms' with the inclusion and overflow of freedom campers. The overflow would be parked in the surrounding streets in the immediate vicinity of the proposed freedom camping Reserves. As these streets would be classified as 'not scheduled' they would be open for unrestricted, unenforceable, and unlimited freedom camping in any vehicle. It is basically opening up the whole of Omaha Beach, a popular and at times overflowing residential beach side area that has little if any available toilet or fresh water facilities, into an unrestricted, unenforceable and unlimited freedom camping hub only an hour from NZ's largest city. This is strongly objected to by the residents and ratepayers of Omaha Beach.

### 4. NO to freedom camping from the residents and businesses of Omaha Beach Public meetings and Survey of Omaha Beach residents on the proposed bylaw

Omaha Beach ratepayers are opposed to freedom camping in Omaha Beach.

We undertook an online survey of our members (those for whom email addresses were held), during a period of one month, from 16<sup>th</sup> January 2019, with a 59% response rate. The survey results show 83% of respondents are against freedom camping in Omaha Beach. In relation to the sites proposed for freedom camping by Council, between 84% - 88% of respondents were against permitting freedom camping there. Full survey results are contained as an Appendix 10

In relation to the survey question "Do you support Council permitting freedom camping at Omaha Beach? 83% of respondents said "No – I do not support Council permitting freedom camping at Omaha Beach, even with restrictions on the use of sites."

In relation to the proposed restrictions on freedom camping sites, there was basically no confidence in these being at all effective, or abided by.

## 95% of respondents answered "No – I do not believe freedom campers will abide by all restrictions."

At the OBC AGM held on 20<sup>th</sup> January 2019, the topic of freedom camping attracted the largest turn out to an AGM in many years. A motion was passed such that the OBC seek a continuation of the current prohibition of freedom camping in Omaha Beach as currently stands under the Rodney legacy bylaws, and the protection given to the proposed sites under the Reserves Act.

A statement from the OSPT has also been obtained. *See Appendix 9* The reasons given are pressure and tension between users already being experienced in the Reserves, lack of basic facilities like toilets and running and drinkable water in the Reserves, issues already being experienced with freedom camping and the negative effect on local business and income, and impact on the conservation areas, if this bylaw went ahead as proposed.

## 5. Evidence of the damage being experienced at Omaha Beach from freedom campers.

The Omaha Beach residents have collected significant evidence as examples of the issues experienced with illegal freedom camping at Omaha Beach, including evidence of human excrement left from campers, fires in conversation reserves, disturbances in the Omaha Beach protected bird sanctuary, parking across multiple car parks restricting other user access, noise, and alcohol. *Appendix 2 shows pictures of this evidence collected over only 2-3 weeks pre this submission.* 

Whilst we have experienced issues with freedom campers in Omaha Beach, we are aware that these may not in fact have been reported to Council – due to Insite Security's current patrols and the frustration by residents in having ineffective enforcement of other bylaws, and frustration with trying to phone Council.

However, we believe the issues experienced in the past will pale into insignificance if the Freedom Camping in Vehicles Bylaw is enacted as proposed.

There is sufficient evidence from other popular areas in NZ through other Council's meeting minutes, press reports and industry body reports, to give us serious cause for concern on the impact of promoted and advertised freedom camping at Omaha Beach.

### 6. Representation and interpretation of the Freedom Camping Act and the proposed Freedom Camping in Vehicles bylaw

We have noted a view by Council (Agenda of the Regulatory Committee meeting 10 August 2017; para 19) stating that ...

"The Freedom Camping Act 2011 allows freedom camping to occur on any local authority area or conservation land, unless prohibited by another enactment. The council may not 'absolutely prohibit freedom camping in its area or district'."

We note that what has actually been quoted in the Council papers is the heading of Section 12 ... whereas the Act (Section 12) actually states the following ...

"(1) A local authority may not make bylaws under section 11 that have the effect of prohibiting freedom camping in all the local authority areas in its district.

(2) This section is for the avoidance of doubt."

The OBC is of the view that the wording of Part 2 Section 12 of the Act, means that, whilst prohibiting Council from making a bylaw that has the effect of prohibiting freedom camping in <u>all</u> the Council areas, banning it in some is not actually excluded by the Act.

Omaha Beach is a residential area, but with unique factors of close location to the centre of Auckland, conservation zones alongside built up residential zoning, and is experiencing pressures from ever-increasing visitor numbers. There is evidence based proof that show the damage and pressure that illegal freedom campaign is doing now to the area and also the learnings as documented in the Council's 'primary harms'.

We do not believe it was ever the intention of the Freedom Camping Act to promote freedom camping in such residential areas as Omaha Beach, and contend that the Freedom Camping Act does allow for prohibition in some areas that require protection. The Freedom Camping Act gives Council the ability to provide a proportionate response to the issues seen. We maintain that a proportionate response to Omaha Beach's unique factors is the prohibition of all freedom camping at Omaha Beach to protect the amenity, access and health and safety of all Omaha Beach residents and visitors to Omaha Beach.

### 7. Protections under the Reserves Act and the Freedom Camping Act

All Reserves in Omaha Beach are protected from Camping under the Reserves Act. These protections are also recognised in the Freedom Camping Act (clause 10b). We note that Council also hold this view as they state they require Ministerial Consent to overturn these protections before freedom camping can proceed in these current Reserve sites.

We note the comment in the consultation documents that delegated authority is held by Council, from the Minister of Conservation. We have obtained a copy of this document ('Reserves Act Instrument of Delegation for Territorial Authorities' dated 8 July 2013). The document was only received by us a couple of days ago, and we haven't yet had the opportunity to fully study it, and obtain a legal view. However, we do question the Council's use of this delegated authority for the proposed purpose, noting the 'general purpose' of the Reserves Act talks of *the preservation of the sites for the public of NZ, and protection of the Reserves from unnecessary subdivision and development.* 

Our view is that permitting 'camping', and the opening up of the reserves to freedom camping as is proposed, especially under the currently documented 'primary and secondary harms' as published by Council, is considered 'development' in this sense, and not is adhering to the 'preservation' and 'protection' of these Reserves.

We object to the proposal to overturn these protections and to permit 'camping' on these Reserve sites and thus create parks for freedom campers.

## 8. Rights of current residents and the vesting in Council of Omaha Beach Reserves for ongoing protection

We believe it was never contemplated that a use, such as 'camping', would ever be permitted on the Reserves when they were created as part of the Omaha Beach development - with homes adjacent to the proposed sites. These reserves were paid for from the developers - and therefore, effectively, the residents of Omaha Beach and vested with Council for protection. We believe it is a huge breach of trust that Council are now proposing to overturn these protections in some of Omaha Reserves.

Those property owners with properties adjacent to the proposed Reserve sites bought there having the comfort of the Reserves Act to prohibit camping, and it would be totally wrong for Council to change this status for the purpose now intended under the proposed bylaw.

## 9. The magnified impact on Omaha Beach of the 'not scheduled' areas in the proposed bylaw.

We are extremely concerned about the proposed revoking of the Rodney District Council General Bylaw 1998: Chapter 8 Public Places. The proposed new Freedom Camping in Vehicles bylaw has almost all of the Omaha Beach residential streets and local resident car parking being classified as 'not scheduled' in the bylaw. There are no general rules given or proposed in these 'not scheduled' areas. We understand consideration had been given by Council to including 'general provisions' in the proposed bylaw, to apply to camping on residential streets, but these were voted down by the Council's Regulatory Committee.

With the non-inclusion of general rules for all other areas of Omaha Beach residential streets and car parking bays and areas, the impact on Omaha Beach is potentially catastrophic, unacceptable, and entirely unmanageable.

As already stated, Omaha Beach has unique factors with its location close to Auckland, and the airport, as well as the hugely popular beach side amenity that is at times overrun with pressures on existing infrastructure. The opening up and promotion of freedom camping at such a renowned and popular beach will result in the overcrowding of any freedom camping space allowances. This will then result in the spilling out across all of Omaha Beach, into its streets and carparks for unlimited, unrestricted, unenforceable freedom camping in any vehicle. The setting up 'camp' outside and beside people's homes is totally unacceptable and, again, we believe was never the intention under the Freedom Camping Act.

Following enquiry to Council, we have been advised that "AT controlled land can be included in the bylaw if there is evidence that a restriction or prohibition is required based on one of the three criteria specified in the Act. If there are specific roads or parking areas that ... (we) has evidence for the need for a restriction on then ... (we) should include this in ... (our) submission and the hearings panel will consider this."

Our argument is that it is unrealistic to specify every street, parking bay and area, for inclusion in the bylaw ... but that freedom camping should be prohibited in all of Omaha Beach.

### 10. Learnings from other cities

All of the other NZ cities include general rules for areas like the 'not scheduled' areas that Council are proposing.

Tauranga, for example, appears to be leading the way in balancing the needs of its people with the requirements of the Freedom Camping Act, and has general rules that allow the protection of access and amenity, and the health and safety of their residents. They state:

Self-contained vehicles only (non self-contained must go to a campground)

You can not camp in front of a private residence or business

Maximum 2 nights stay

Wellington, Christchurch and Dunedin have also self-contained requirements.

Auckland, as NZ's largest and most populated city, needs to prioritise the needs of its ratepayers and residents.

## 11. Omaha Beach meets the standards of being a HIGH /HIGH on the Council's matrix rating - requiring PROHIBITION

The unique factors of Omaha Beach classify it in the Council matrix utilised to determine freedom camping restrictions - as Level of Protection needed HIGH, and Desirability to campers HIGH. On this basis Omaha Beach and its residential streets and car parking bays and areas MUST have the protection required from freedom camping to protect the amenity, accessibility, and health and safety of its visitors, its residents, its ratepayers and its conservation environment.

The Council are within its rights under the Freedom Camping Act to put in place prohibition to areas that require protection of the amenity, accessibility and health and safety of the people and the area. All evidence presented here, both written and photographic, clearly states and shows the required prohibitions on freedom camping is needed for Omaha Beach.

### 12. Sites selected and proposed as prohibited are supported by Omaha Residents

We recognise that the two sites in Omaha Beach designated by Council as prohibited in the bylaw proposal are reserves where camping is currently prohibited as covered in the Reserves Act. We agree that those two Reserves must have their prohibited status continued under any new bylaw and highlighted with signage to this effect. The sites are 223 Omaha Drive (Omaha Beach Boat Launching Ramp and Wharf); and 15 North West Anchorage (Omaha Reserve).

### 13. Unsuitability of the proposed 'restricted' sites designated by Council for Omaha Beach

The sites selected and proposed by Council as 'restricted' sites' are all currently protected under the Reserves Act and remain protected under clause 10.b in the Freedom Camping Act. These sites being opened to freedom camping are objected to by the residents of Omaha Beach and we request that the current protection from camping in these Reserves remains in place. We suggest that appropriate and proper signage be erected to notify of the no-camping status of these protected Reserves – as well as at the entry to Omaha Beach itself. These Reserves are already stretched at peak periods and do not have the infrastructure to handle current usage now, before the addition of over-night freedom camping – even if it was restricted to certified self-contained vehicles only. Council commissioned report 'Rodney Public Toilet Provisions March 2018' stated "The public toilet provision in Omaha is insufficient to meet the demand from both locals and tourists".

The Reserves proposed by Council as restricted freedom camping sites are:

- Pukemateko Reserve, 177 Mangatawhiri Rd
- 160 Omaha Drive (Rita Way, Excelsior Way, Lagoon Way
- William Fraser Reserve, 37 Broadlands Drive

### Pukemateko Reserve, 177 Mangatawhiri Rd

Proposed by Council as a 'restricted' site. This site is not supported by the local residents and businesses of Omaha. Note please see Appendix 4 for photo evidence of the following points

Reasons being:

- This Reserve is surrounded by residential properties fronting onto the Reserve, who will be severely impacted by the proposed change in status from the current prohibition of camping that remains in place.
- It is immediately adjacent and in full view and sound zone of a fully built up residential area. (See Appendix 4).
- This site has NO running water, NO public toilet facilities, and is a busy and at times overflowing public car park for day visitors and locals (see Exhibit 3)
- There is only one rubbish bin
- The protected Reserve is also a popular and safe children's playground. Appendix 4
- The car parking area is popular for 'surfies' who often surf at the southern end of the beach.
- The current experience from illegal camping in this reserve is that because parking and turning is tight and set for cars, illegal campers park horizontally across multiple parks taking significantly greater space that one carpark. See *Appendix 4*
- The site is a busy residential car park and is not large enough to allow the safe entry, exit and manoeuvrability required for a standard 2 berth camper van and would require substantial earthworks to accommodate these. As shown in an independent review *Appendix 3*
- The suggestion is 3 freedom camping parks; certified self-contained vehicles only, Although 3 parks are proposed, with no active Council funded enforcement, this will not prevent greater numbers using the area and setting up camp, as recognised in "primary harms" in Council's own documents. It is considered highly unlikely freedom campers will vacate the sites during the daytime.
- The overflow from this site will have no barriers to moving into the adjacent residential streets that will be classified as 'not scheduled' and will result in unenforceable, unlimited and unrestricted freedom camping for an indefinite period in these streets.
- Prohibition is required to protect access to this area.

Our survey asked for views on the Council's 3 proposed sites for freedom camping. In relation to this site, 84% of respondents answered "No – I do not support Council's proposal to have (restricted) freedom camping in the car park at Pukemateko Reserve, 177 Mangatawhiri Rd, Omaha South." See Appendix 10- OBC Survey Results

### 160 Omaha Drive (Rita Way, Excelsior Way, Lagoon Way)

Proposed by Council as a 'restricted' site. This site is not supported by the local residents and businesses of Omaha. *Note please see appendix 5 for photo evidence of the following points* 

Reasons being:

- This site is the location of the overflow boat trailer parking, and is utilised heavily throughout summer not just by the residents of Omaha Beach, but also the surrounding areas. *Appendix 5*
- This site is also surrounded by residential properties, who will be severely impacted by a proposed reversal of the current prohibition of camping as covered in the Reserves Act with this prohibition remaining in place under 10.b of the Freedom Camping Act.
- There is no running water, no toilets and 1 rubbish bin.
- The site is a small car park utilised for overflow boat ramp parking and does not have a large enough hard stand area to allow the safe entry, exit and manoeuvrability required for a standard 2 berth camper van and would require substantial earthworks to accommodate these. As shown in an independent review *Appendix 3*
- It is proposed by Council as 'restricted', with 2 freedom camping parks; certified selfcontained vehicles only.
- With no additional funding being proposed by Council to enforce the rules, as recognised in the "primary harms", it is we believe it is unlikely freedom campers will vacate the site during the daytime and leave the area free for use by the boating residents and visitors, and for the use it was established and intended.
- 2 parks are proposed and any overflow will be able to move to immediately surrounding residential streets and resident carparks as these are classified as 'not scheduled'. Campers will be permitted to set up camp overnight in their non-self-contained vehicles indefinitely in "not scheduled" areas.
- Prohibition and signage is required to protect access to this area.

In relation to this site in our survey, 88% of respondents answered "No - I do not support Council's proposal to permit restricted freedom camping at 160 Omaha Drive ..."

### William Fraser Reserve, 37 Broadlands Drive

Proposed by Council as a 'restricted' site. This site is not supported by the local residents and businesses of Omaha. *Note please see Appendix 6 for photo evidence of the following points* 

### Reasons being:

- Currently proposed by Council as a 'restricted' site, with 5 freedom camping parks, but with 'non self-contained' vehicles permitted.
- This is the main Reserve and car parking area in Omaha Beach, located adjacent to commercial premises and the Surf Life Saving Club, and the main access to the beach itself.
- This Reserve is prohibited for camping under the Reserves Act
- The Reserve is also surrounded by established residential houses.
- There are only very limited toilet facilities, and an outside shower, all as <u>part</u> of the Surf Life Saving Club building. These facilities are already under immense pressure. *Appendix 6*
- There is no potable water supply it being from a bore. There is a question mark over the continued availability of these facilities to the public, due to the impact it is having on the Surf Life Saving Club itself, with the public just expecting to also use the facilities in their clubrooms, and theft of property from the premises.
- These facilities are locked at night due to prior issues from night time disturbances.

- The car park currently cannot enable safe manoeuvring of campervans (2-4berth) and would require substantial earthworks. The resulting loss of parks is estimated at over 16. This assessment work was completed for the OBC by an independent planner. Losing multiple car parks to larger camping vehicles has an impact on reducing already insufficient parking in this area see *Appendix 3*
- The public car park area is already bursting and overflowing during busy times Appendix 6
- With advertised and promoted freedom camping it is logical to anticipate a significant oversubscription of night time campers. The overflow would go into the nearby residential streets and car parks which are classified as "not scheduled" and lose the protections under the Rodney Bylaw 8 when revoked. This will create unrestricted, unenforceable, unlimited freedom camping in non-self-contained vehicles being permitted in Omaha Beach streets.
- The overflow into 'not scheduled' areas creates a disproportionate impact on the health, safety, amenity and access to Omaha, its residents and its visitors.
- The proposed restriction to permit non self-contained vehicles at this site is entirely inappropriate it would have needed to be certified self-contained vehicles only due to the non-access and unsuitability of the toilet and water facilities nearby.
- We also believe other restrictions should also have been imposed, such as times to arrive at, and vacate the site by, for campers in vehicles.
- However, our lack of confidence in freedom campers adhering to any such restrictions and our current experiences of freedom camping harms already experienced at Omaha, together with the lack of Council funds designated for adequate enforcement, would make the restrictions totally ineffective.
- Prohibition is required to protect access to this area

In relation to this site, 84% of the survey respondents answered "No – I do not support Council's proposals to permit restricted freedom camping in the car park at William Fraser Reserve, 37 Broadlands Drive."

## 14. Ignoring Health and Safety standards impacting safety of all users in areas allocated for Freedom Camping

We are of the view that there is also health and safety issue with vans being parked, occupied overnight, and too close together with cooking inside with gas bottles. We have noted that the Camping-Ground Regulations require a minimum level of separation ... "No temporary living place shall be erected or placed on any camp site within 3 metres of any other temporary living place, or within 1.5 metres of any camp site boundary, as the case may be".

Wouldn't this health and safety requirement apply also to gas cooking within vans? We find it unusual that Council would suggest (as noted in Meeting Minutes of 13 September 2018), that the safety of those people utilising the carparks with freedom campers and for those freedom campers themselves, would be allowed at a lower level of safety than that applied to camping grounds. We cannot understand why the health and safety of those people would be protected in any less of a way than that covered in camp grounds. By applying the health and safety requirements for the safety of ALL users of the carpark, this would require the significant over taking of multiple more carparks than proposed, in what is already limited carparks in the designated freedom camping carparks in Omaha Beach.

We note from Council papers (Regulatory Committee meeting 13 September 2018 – para 64) that Council are aware of this issue, and where it was stated ... *"Feedback from local boards and community stakeholders included that campers should be at least three metres apart to align with the regulations imposed on commercial campgrounds. While this is a relevant consideration for fire*

safety, it is impractical to implement within existing infrastructure and will reduce the number of camping areas on a site." ...

Of some considerable concern to us, Council would appear to have chosen to just ignore this issue ...and place people at risk!

The location of Omaha Beach, being on the east coast is, unfortunately, at risk in the event of a Tsunami. Whilst we are able to (and do) educate Omaha Beach property owners of the risks and actions to take in the event of a warning or the sirens sounding, we are unable to do the same for freedom campers – potentially putting them at a greater risk.

In relation to the proposed parking spaces for freedom campers at the 'restricted' Reserve sites, the currently marked parking spaces are designed primarily for cars. Camper vans these days are of a size such that they cannot be accommodated in one of these marked parks. We have seen evidence of vans actually parking sideways across 5 car parks! – see photos in *Appendix 2*. To evidence this issue, and the pressure the proposed bylaw will place on the limited number of parking spaces we currently have, we have had a plan / theoretical layout of the sites drawn up, allowing the minimum distances, etc between vehicles, and showing the car park modifications that would be required to accommodate the length of an RV camper van. *See Appendix 3*. This would therefore see a considerable number of the existing marked car parks taken over to provide a small number of freedom camping parks – at additional cost to Council (and its ratepayers).

## 15. Evidence shows restrictions are broken and Council do not adequately resource enforcement

In terms of the 'restrictions' on the sites proposed – these provide little or no comfort. The results of our survey show that Omaha Beach ratepayers have overwhelmingly expressed the view that not all freedom campers will abide by restrictions placed on sites (95% of respondents do not believe freedom campers will abide by restrictions). Evidence at Omaha Beach shows this is already the case. Although the number of freedom camping parking spaces proposed is limited, which we acknowledge, we fail to see how this can be managed to ensure only those numbers are used, and that they will only be used only at night and be vacated during the day. We fail to see how length of stay can possibly be managed, unless sites are inspected daily. If required to vacate parking spaces during the day, where is it anticipated the vans will move to – the 'not scheduled' areas of Omaha Beach? There also appears to be no mention of a time of day that vans can park there to commence their overnight stay.

In relation to our survey, we asked about their confidence in Council being able to adequately enforce any restrictions. 94% of respondents answered "No – I don't believe Council will be able to adequately enforce any non-compliance with the restrictions."

Enforcement of the 'restrictions' is also an issue as reflected in the Council's 'primary and secondary harms' document. From our survey, the residents of Omaha Beach strongly expressed the view that any restrictions will not be adequately enforced by Council (94% of respondents do not believe Council will be able to adequately enforce non-compliance with restrictions) – hence our request for the appointment of Insite Security as an 'enforcement officer' for Omaha Beach. See Section 17; and Appendix 8

## 16.Council breaking their own guidelines on how to minimise primary and secondary harms in Omaha Beach

We maintain that the sites selected at Omaha Beach contravene the Council's own guidelines for mitigating primary harms.

Council have selected sites that are the most popular and already under intense pressure by locals and visitors.

Council have chosen sites that are the most convenient and attractive.

Council have chosen sites adjacent to residential properties, and right in the middle of view shafts and adjacent to children playgrounds.

We note from Council Regulatory Committee meeting agenda and minutes (10 August 2017), that the intent of the bylaw is to address the harms from freedom camping ... *"Managing primary harms:* 

30. The problems associated with freedom camping can be divided into two problem types. 31. The first type is managing direct impacts or primary harms. These are intrinsic to the activity of freedom camping. They are generally unavoidable, though they can be mitigated to reduce their impact. Primary harms can be summarised as:

- loss of visual amenity due to presence of campers
- noise and other emanations, e.g. cooking smells
- conflict between other users including local residents
- blocked views
- privatisation of public space.

However, we do not believe these primary harms have in fact been adequately addressed, and nor will they be adequately managed In Omaha Beach, with the Council's proposed bylaw.

### 17. Requirement for an enforcement officer at Omaha Beach

We also request the appointment of an 'enforcement officer' for Omaha Beach, in terms of Subpart 3. Section 32 of the Freedom Camping Act, to be given powers to enforce a prohibition, and any restrictions, in relation to freedom camping in Omaha Beach (which is an area easily defined). Our request for a local warrant to be granted results from the community's belief that not all freedom campers will comply with a prohibition, or restrictions; and Council officers will not be able to adequately enforce a prohibition or restrictions. To support this request, and based on our experience locally with the lack of enforcement of existing bylaws (such as Set Netting; Liquor bans; and the hours dogs are permitted on the beach); and we fail to see how, as noted in Council papers, the enforcement can possibly be improved – to address the primary harms noted above - when, in those same Council papers, it is stated that "*Resourcing to enforce the bylaw will therefore be met from existing baselines*".

The OBC has, for a number of years now, contracted with Insite Security Ltd to provide security patrols in Omaha Beach – particularly over the peak holiday periods when the number of properties occupied increases, and the number of visitors and day trippers (and issues) swells significantly. In patrolling Omaha Beach, including the beach itself, they have been able to suppress potential problems and 'hot spots' – including breaches of the various bans and bylaws in place at Omaha Beach. These bans and bylaws include the hours dogs are permitted on the beach; the set netting ban; and alcohol bans – where we have found the Council officers unable to effectively manage and enforce these bans and bylaws. Issues discretely dealt with by Insite Security to protect people and property, and the natural environment, include fires on the beach; cleaning rubbish from the beach; gatherings on the beach with alcohol, in breach of the alcohol ban; noisy parties and traffic offences etc. In handling these situations, Insite Security also deal closely with the appropriate government and Council authorities.

It is therefore considered appropriate, and necessary, for Insite Security to be appointed as an 'enforcement officer' to ensure the prohibitions and restrictions in relation to freedom camping at Omaha Beach are adequately enforced.

Details for Insite Security form part of this submission - See Appendix 8

### 18. Alternative options and sites for ALL camping in the area

In requiring the prohibition of freedom camping in Omaha Beach, we would note that there is an abundance of alternative camping facilities nearby. Some require stayers to pay, what appears to be a nominal amount, and certainly a nominal amount for the location and facilities provided:

- Whangateau Holiday Park <u>https://www.whangateauholidaypark.co.nz/</u>. The most obvious of locations for this area – and operated by Auckland Council! Situated on Whangateau Harbour, east of Warkworth and near Leigh in the Matakana Coast area, with sites right on the waterfront.
- Martins Bay Holiday Park <u>https://www.martinsbayholidaypark.co.nz/</u>. Again, operated by Auckland Council! Why not encourage greater use of the Council operated facilities nearby, and increase income, rather than make ratepayers pay for the cost of putting in place new freedom
  - camping parks at locations where those same ratepayers don't want them?

- 8. Snells Beach- current provision in two reserves for freedom camping
- 9. Mathesons Bay –current provision for freedom camping
- 10. Warkworth camp ground
- 11. We also learnt at the 'drop in session' in Warkworth, on 16 February, that the Council owns what we believe to be a 2 acre site at Baddeleys Beach of which no mention appears to have been made in the Council consultation papers. Unfortunately, with this 'drop in session' being so close the closing date for submissions, we have not had sufficient time to fully investigate this site further. However, we understand it is the perfect freedom camping site for the area originally having been purchased by Council for a camping ground. Council should therefore investigate this site further, and seriously consider it as a suitable alternative to the other proposed sites in the immediate area.

## In our survey, we also sought feedback regarding possible alternative sites considered suitable for freedom camping. Examples of responses were: *Appendix 10*

"No. The prohibition on freedom camping in Omaha must continue. This is a residential area!"

"We consider the best spot for freedom campers in the area to be the Warkworth Showgrounds where there is ample room, public toilets and rubbish facilities, no near residents. They can commute to the beaches and surrounding regional parks just like the local rate paying public have to."

"It is there now - 50 per cent occupancy rate, just upgraded in line with Council requirements - this is where FCs stay!" We believe this comment was referring to 'Happy Dayz Backpackers' on Omaha Flats Rd – see Section 17.

"No - the residential nature of omaha does not suit freedom camping . There are no suitable sites with at least 200 metres to closest residential property and parking facilities are already stetched to the max ." "Self contained vehicles only on spare land next to cafe on Omaha Flats Road before you drive over causeway into Omaha. Must pay \$10.00 per person per night, maximum 2 nights and a code will be released once payment is made. Just like ARP."

With Council operated holiday parks in the area it seems inconsistent that Council would be pushing the freedom camping angle so hard, underpinning the viability of ratepayers businesses and privately owned businesses. Surely you would want to encourage greater use of your own facilities first – to partially offset the costs that will be incurred with the proposed freedom camping sites. These holiday parks are also in scenic spots – and not in a residential areas.

We note it is also inconsistent that Council have prohibited freedom camping near or alongside its own managed camping facilities where management and negating of primary and secondary harms could be easily handled by council staff. Instead of this option they have pushed freedom camping into the heart of residential areas and areas under significant pressure with no plan nor additional resources to enforce or manage these sites.

We also note that we have had very preliminary, informal, discussions with a party who has expressed interest in providing an attractive site for freedom campers close by Whangateau Harbour

### 19. Final statement

We acknowledge that, in terms of Section 11 of the Freedom Camping Act, the bylaw must be the most appropriate and proportionate way of addressing the perceived problems in the area and, based on this submission, we maintain that the desirability of Omaha Beach to campers together with the unsuitability of the sites means that prohibition of freedom camping in Omaha Beach is the most appropriate and proportionate response.



- Over flows into the streets that will be designated 'not scheduled' showing where freedom campers will go when the designated spots in car parks are full.





### Omaha parking Assessment

14 February 2019

### Introduction

Hale Design Limited (HDL) has been engaged to assess the current carpark designs in three locations to accommodate freedom camping vehicles.

Parking sites assessed are located at;

- Omaha Surf club, 57 Broadlands Drive, Omaha.
- 160 Omaha Drive,
- 177 Mangatawhiri Drive

While the by law proposes accommodating 6 vehicles (including self-contained and non-self-contained) this assessment has looked at accommodating only 2 motorhomes due to the high overall loss of carpark spaces and the extent of civil works required to allow for vehicle manoeuvring.

#### Overview

The Freedom camping act refers to a tent or other temporary structure, a caravan, a car, campervan, house truck or other motor vehicle.

While most public parking demand is for light vehicles and can be met by standard sized parking spaces when accommodating parking by campervans a dedicate parking area and turning / manoeuvring areas are required to suit the vehicle type and design.

A standard 90 Carpark size in New Zealand allows for an overall width 1.870m x overall length of 4.910m and a turning circle of 6.28m minimum radius to the outer wheel. Minimum NZ dimensions for a carpark is 2.3m wide x 4.5m long.

#### **Proposed parking details**

For this assessment HDL has used the standard size of a kea motorhome of 2m wide x 7.0m long for a 2-person up to a 2.25m wide x 7.1m long for a 4-person, this size vehicle has a turning circle of 9m minimum radius to the outer wheel. Taking into account the campsite regulations stating No temporary living space shall be erected or placed on any camp site within 3 metres of any other temporary living place and including area for a standard kea awning the parking dimension indicated reflect the width and accommodate the length associated with the standard sized motorhomes. Cars towing caravans are not reflected in the proposed plans as the overall length of the vehicle including a caravan length increases to 11.5m.

#### Assessment findings

#### 57 Broadlands Drive (Omaha Surf club)

This existing parking site services the reserve, surf club and beach with an existing number of Carparks totalling 151. The current one-way carpark layout, parking dimensions and circulation width cannot accommodate the standard camper van supplier and hired by leading NZ camper van hire company Kea. Current carpark layout would need substantial ground, garden and tarmac works to redesign the carpark to ensure safe and legal movement of the standard camper van.

If no civil works are undertaken a camper cannot navigate the existing s-bend road design and with the one-way traffic flow would in most instances drive straight into the wrong traffic flow and have to reverse out of the carpark. If they did try to navigate the existing s-bend design they will have to drive up kerbs, over gardens and potentially collide with other parked vehicles. There is no way to indicate at the entry of the carpark if the 2 allocated areas are available and the campers would need to drive through the entire carpark before exiting.

In most cases the drivers will try and reverse out back onto the road. As per the regulations Reversing movements to public roads shall be prohibited wherever possible.

To allow the inclusion of 2 camper van sites significant civil works to increase the s-bend corner design and improve the road layout within the carpark is required to ensure movement of camper vans around the carpark, clear oneway traffic marking would be imperative to ensure correct direction of travel as there is no room to complete a Uturn within the parking footprint if the carpark is full. The proposed layouts would result in the reduction of between 13-16 carparks to allow for the inclusion of 2 camper sites.

#### Site Summary

This existing parking site services the reserve, surf club and beach with an existing number of Carparks totalling 151.

- Option A New number of carparks 135 & 2 dedicated motorhome sites
   Total loss of carparks Option A = 16
- Option B New number of carparks 138 & 2 dedicated motorhome sites Total loss of carparks Option B = 13

#### 160 Omaha Drive

The existing site is currently used as an overflow parking area for the boat ramp and the majority of trailers park on the grass.

If no civil works are undertaking a camper can enter the site but would need to travel outside the existing footprint of the parking area on the grass to complete a full U-turn to allow for safe exit forward out onto the road. This manoeuvre could be undertaken if the carpark was empty but if there were a couple of cars with trailers located on the site this manoeuvre would be impossible and the camper would have to reverse out of the carpark onto the road. As per the regulations Reversing movements to public roads shall be prohibited wherever possible.

In the current footprint to allow for the campers to enter the dedicated site then reverse and manoeuvre out of the site before exiting the parking area and travelling forward onto the road results in the majority of the site designated as No parking/turning area.

To allow for the inclusion of 2 camper sites once carpark civil works have been completed to ensure movement of camper vans around carpark would result in the reduction of 11 carparks to allow for the inclusion of 2 camper sites, leaving parking for only 3 vehicles.

#### Site Summary

This existing parking site services vehicle & boat trailer parking

- Existing number of Car/trailer parks 14
  - o Proposed number of car/trailer parks 3 & 2 dedicated motorhome sites
  - Total loss of carparks = 11
  - o New parking area requires 160sq.m of additional grass reserve to be sealed.

#### 177 Mangatawhiri Drive

This existing parking site services the reserve and beach with an existing number of Carparks totalling 42. The current carpark layout, parking dimensions and circulation width cannot accommodate the standard camper van supplier and hired by leading NZ camper van hire company Kea. Current carpark layout would need substantial ground, garden and tarmac works to redesign the carpark to ensure safe and legal movement of the standard camper van.

If no civil works are undertaken a camper can enter the site (only if there is no vehicle exiting at the same time) but once inside the existing footprint has no space to manoeuvre and would need to reverse back onto the road if there were cars located within the parking site.

### Omaha Beach Community Inc. Appendices to Submission re Proposed Freedom Camping in Vehicles Bylaw

Any camper would need to travel outside the existing footprint of the parking area on the sand / grass to complete a full U-turn to allow for safe exit driving forward out onto the road. This manoeuvre onto the sand / grass could be undertaken (depending on ground conditions in wet months) if the carpark was almost empty but if the carpark was more than 50% full this manoeuvre would be impossible and the camper would have to reverse out of the carpark onto the road. As per the regulations Reversing movements to public roads shall be prohibited wherever possible. The site is designed for two-way standard light vehicle traffic and is not wide enough to allow for the longer vehicles and major works to the site will be required to accommodate the length and width of a camper.

After civil works to increase the entry to the parking, relocation/removal of existing carparks and extending the parking area to allow for the parking and manoeuvring of the campers to allow for safe forward exit to the street the inclusion of 2 camper van sites would result in the reduction of between 11-14 carparks.

  - Total loss of carparks Concept B = 14
  - o New parking area requires 295sq.m of additional grass reserve to be sealed.

#### Conclusion

All of the existing parking sites assessed are not suitable for camper parking within the existing footprint and significant civil works and extensions are required to allow for the manoeuvring of larger vehicles (7.0-7.1m) within the sites all resulting in a loss of existing parking spaces.







### Re: Proposed freedom camping sites at Omaha

I am writing on behalf of Omaha Shorebirds Protection Trust (OSPT) regarding the proposed Freedom Camping sites in Conservation Zone areas at Omaha.

The Omaha Shorebird Protection Trust was established in 2009 to protect shorebirds that breed and flock at Omaha Spit at North Omaha Reserve, and other native species that are unique to our coastal habitat. Although our group focuses on protection of North Omaha Reserve, Omaha has a number of other conservation areas of ecological importance that must also be protected, including Taniko Reserve, Omaha South Quarry Reserve, the dunes and foreshores.

OSPT therefore oppose the establishment of freedom camping sites in Conservation Zone areas at Omaha for the following reasons:

- (i) There has been a large increase in visitors to Omaha over the last two summers, with more people using North Omaha Reserve for swimming and beach recreation. This is having a negative impact on the breeding success of Northern NZ dotterels and variable oyster catchers as people on the beach prevent the chicks from accessing the edge of the tide to feed. Establishing freedom camping sites at Omaha will mean more people on the beaches inside the bird sanctuary for longer.
- (ii) We have already observed an increase in rubbish (food packaging, bottles/cans, & toilet paper) left lying about where people have camped. This is not only unappealing for locals that live nearby, but also attracts predators that threaten our shorebirds.
- (iii) Many campers take their pets with them. One cat escaping from a campervan overnight could wreak havoc with wild life. Although we have a predator fence in place to protect the shorebirds, the ends of the fence are "leaky", providing easy access for roaming cats and dogs. Our shorebirds nest on the ground, and are therefore easy prey for cats and dogs.
- (iv) Finally, we are not confident that any freedom camping rules and regulations would be rigidly enforced. Our experience with Auckland Council regarding dog control at Omaha suggests freedom camping would fast become "free-for-all" camping.

### Appendix 10: Omaha Beach Community Inc. Survey Results Summary Survey Results

The OBC undertook an online survey of its members (those for whom email addresses were held) for a month from 16<sup>th</sup> January 2019.

In total 901 emails inviting participation were sent (this excludes those where the emails 'bounced' or they had previously 'opted out' of such emails).

We received a total of 533 responses – a response rate of 59% - to the survey (although it is not unreasonable to deduce that this represents up to twice that number when individuals and multiple owners of properties are taken account of).

The full survey results are attached, and reference to them has been made throughout this submission.

The survey invited (at the end of it) respondents to make any other, general comments, they would like to in relation to Freedom Camping at Omaha Beach. These comments are an example of the vast majority of sentiments expressed.

"Omaha is a fully built up residential area, visitors to Omaha should be limited to day visits only. There is no reason why visitors should be able to camp in their vehicles overnight when there are designated camp areas close by with full facilities."

"as ratepayers we woud be ultimately paying for Freedom Campers. The existing facilities cannot cope as it is. Toilet blocks are already inadequate and rubbish bins are overflowing a day prior to rubbish collections. All car parks are too close to homes and would therefore be noisy with opening and closing doors, conversation and music."


" Visitors are welcome to enjoy omaha during the day however i do object to using our ratepayer money to police and provide facilities to people who do not contribute in any meaningful way to the community. Freedom camping will not improve the investment residents have made in owning property especially in close proximity to any proposed sites. Let them go away at end of day to a purpose built camping ground and come back tomorrow if they so wish - seems logical and a lot less work for locals like myself"

"I am not apposed to Freedom Camping per se but feel there are enough issues to deal with in Omaha already i.e. dogs, rubbish, speeding traffic, set nets and alcohol consumption, with very little enforcement being applied."

"There are no appropriate sites here at Omaha. The Council's recommended sites would all have negative effects on the surrounding neighbours. As it is the infrastructure here struggles to cope with the seasonal influx of residents. Any freedom camping would further impact on that"





### Q2 Do you support Council permitting freedom camping at Omaha Beach?







### Q4 Do you think that Council will be able to adequately enforce any noncompliance with the restrictions?








